We are pleased to inform you that due to the actions of the Federal government, the Free & Reduced Lunch program is making Free Lunch available to all students in participating schools until the end of the 2020 - 2021 school year. (previously this program was to end on December 31, 2020.) St. Francis has chosen to participate in this extension of the Summer Food Service Program.

What does this mean for our students at St. Francis Xavier School?

1. It means that ANY child attending SFX school is able to receive a hot lunch free of charge on any day that they attend school during the time period stated above. We will continue to follow our normal procedures for ordering hot lunch.
2. If you would normally fill out a free & reduced lunch application, we ask that you still fill out the application so that when this school wide free lunch period is done, we will already have the information needed to seamlessly move back to the normal mode of operation
- 3. If we should need to move to distance learning at any point in time, or if you find yourself food insecure at any point in time, please refer to our other links found on the SFX website under School Information: Lunch, for other resources for you and your family.**
